# Katz's Deli Visiting Lecturer Presentation Contract

This agreement is made on July 5<sup>th</sup>, 2017 between /// 1014 the Ke/XJEK (Brunch Participant, "BP"), Amanda Martin Katz (Visiting Artist, "VA") and the Azusa Pacific University Department of Art (APUDoA), for the "Visiting Lecturer Presentation" scheduled to commence at 12pm and close at 1:30pm.

## Agreement

1. Amanda Martin Katz (Visiting Artist) has been invited by the Azusa Pacific University Department of Art (APUDoA) to provide one lecture regarding but not limited to her artistic practice over the course of a midday meal.

## Section A. Food

- 2. APUDoA agrees to provide all food and food-related infrastructure in connection with this event. This provision includes paying for and coordinating the delivery and set-up of all edible and non-edible lunch related items.
- 3. APUDoA agrees to provide bagels, lox, cream cheese, tomatoes, lemons, red onion, capers, sandwiches, coffee, tea, and water to accommodate a minimum of 35 BPs.
- 4. VA does not compel APUDoA to acquire the food from a traditional Jewish delicatessen, and allows APUDoA to locate the agreed upon food items from any vendor as APUDoA sees fit. VA apologizes to the BP's in advance of the meal in the event that APUDoA's chosen catering service does not satisfy the gustatory expectations one may have upon referencing "Katz's Deli."
- 5. BP's must agree to the terms and conditions of this agreement in order to participate in the edible portion of this "Visiting Lecturer Presentation."

#### Section B. Lecture

- 6. APUDoA agrees to provide a projector and lecture stand, which the VA is not required to utilize in the delivery of the lecture.
- 7. Only the delivery of a lecture by the VA is required. It is not required that the lecture be of any particular qualification (eg. useful, interesting, passionate).

## Section C. General Event and Compensation

- 8. Photographic documentation of the event by APUDoA must be shared with the VA, and the VA agrees to credit APUDoA when reproducing said documentation.
- 9. In the event that photographic documentation is uploaded to social media platforms by APUDoA and/or BPs, it must be accompanied by the hashtag #KatzsDeli and tagged with @amkatz.
- 10. Compensation for the VA's intellectual, physical, and emotional labor is provided in the monetary form of \$600.00 but is not limited to it.
- 11. In the event that BPs who are also MFA students sign up for post-lecture studio visits with the VA, the VA will remain on campus until 5pm and the monetary rate of

compensation will not increase. Studio visits are limited to MFA students who have participated in the mealtime "Visiting Lecturer Presentation."

# Section D. Liability

- 12. In the event that either APUDoA or the VA is unable to fulfill his/her obligation due to damage or destruction of the venue by fire, verified disability of the VA, acts or regulations of public authorities, labor difficulties, civil tumult, strike, or epidemic, neither APUDoA nor the VA will be held legally responsible for any damages arising from the cancellation of the "Visiting Lecturer Presentation." Cancellations or changes of date for reasons other than those listed above will render VA liable for any expenses, documented in writing, incurred by APUDoA in connection with this event.
- 13. APUDoA will indemnify VA for any liability VA may incur to BPs or other third parties by reason of VA's actions, both lecture-event and non-lecture-event related.
