# Katz's Deli Artist Contract

This agreement is made on 1/1/2016 between Amanda Martin Katz (HOST) and Axiologue (GUEST) for the Katz's Deli session beginning on 1/1/2016 and ending on 12/31/2016.

## Agreement

- 1. Axiologue (GUEST) is in thought-residence with Amanda Katz (HOST) for the duration of the year of 2016. HOST commits to actively witness and facilitate the conceptual and aesthetic development of GUEST through monthly processing and idea development sessions that may take place physically and/or virtually.
- GUEST is invited to be in physical residence at Katz's Deli, located at 3307 W Washington Blvd, Los Angeles, CA 90018, for the week of November 13<sup>th</sup> to November 20<sup>th</sup> 2016, culminating in a public "Deli Event" to be co-hosted by the parties.

### Section A. Time/Labor

- 3. Beginning January of 2016, HOST and GUEST agree to be either physically or virtually present for monthly thought-sessions leading up to the fall residency period. Additional meetings may be scheduled at the discretion of both parties.
- 4. HOST and GUEST are equally responsible for the physical installation and deinstallation of all materials, both artistic and edible, pertaining to the "Deli Event."
- 5. GUEST has no obligation to involve HOST in any future development of itself as an entity, and HOST agree to claim no stake, either authorial or financial, in the future manifestations of GUEST. HOST has no obligation to advise GUEST in any capacity post-December 31<sup>st</sup>, 2016.

## Section B. Space

- 6. HOST offers use of residence at 3307 W Washington Boulevard, Los Angeles, CA 90018 for the above specified residency period.
- 7. GUEST is allowed to invite additional guests into the space for studio visits, meetings, and other Axiologue-related activities. GUEST is not allowed to use the space as a personal residence.
- 8. GUEST agrees to comply with the terms and conditions of HOST'S lease with landlord Ben Reininger, dated January 1<sup>st</sup>, 2016, a copy of which has been provided. GUEST agrees to be responsible for any breech of said lease by the GUEST or any invited party.
- 9. GUEST understands that this arrangement is not a sublet or assignment of the aforesaid lease. Nor is GUEST entitled to receive any compensation in connection with this arrangement.
- 10. GUEST has free use of the space in terms of installation/construction/intervention for the "Deli Event" while adhering to the rules laid out in the original property lease agreement between Amanda Martin Katz and Ben Reininger.
- 11. GUEST is responsible for returning the space in a cleanly manner. HOST and GUEST are equally responsible for returning the space to its original condition within 24 hours of the "Deli Event."

### Deli Event

- 1. HOST and GUEST are equally responsible for the installation and de-installation of the "Deli Event" on Sunday, November 20<sup>th</sup> 2016.
- 2. HOST agrees to have one projector, mac mini, wireless keyboard and mouse, and extension cords available for the installation.
- 3. HOST agrees to provide three 8'x40" tables for the "Deli Event."
- 4. GUEST agrees to provide three 8'x40" vinyl tablecloths for the brunch.
- 5. HOST agrees to provide the dry goods (plates, forks, knives, cups, napkins and serving utensils).
- 6. GUEST agrees to provide 6 jugs of water.
- 7. HOST agrees to provide all food.
- 8. HOST agrees to arrange for photographic documentation of the event. HOST retains all image rights of event documentation, and must be credited when used by GUEST in subsequent publishing (re: Image courtesy Katz's Deli). Any other form of documentation (eg. handwritten, digital) produced within the duration of the "Deli Event" is the sole property of Katz's Deli and will be made available to GUEST at HOST's discretion.
- 9. HOST and GUEST commit to be of sound mind for the duration of the "Deli Event." Sound mind is characterized by, but is not limited to, curiosity, openness, patience, and passion. Evidence of sound mind includes but is not limited to deliberate vocabulary and listening to others.

### Liability

- 10. In the event that either HOST or GUEST is unable to fulfill his/her obligation due to damage or destruction of the venue by fire, verified disability of the GUEST, acts or regulations of public authorities, labor difficulties, civil tumult, strike, or epidemic, neither the HOST nor GUEST will be held legally responsible for any damages arising from the cancellation of the residency or "Deli Event." Cancellations or changes of date for reasons other than those listed above will render GUEST liable for any expenses, documented in writing, incurred by HOST in connection with this event.
- 11. GUEST agrees that HOST will not be responsible for any personal injury or property damage GUEST may incur on the premises. GUEST will indemnify HOST for any liability HOST may incur to third parties by reason of GUEST's actions, both art and non-art related.
