If BODY CLAMP elects to perform notwithstanding a breach of this agreement by Katz's Deli, the performance by BODY CLAMP shall not constitute a waiver of any claim BODY CLAMP may have for damages or otherwise.

A. ADVERTISING AND PROMOTION

A1. Billing on all advertising and publicity must appear as follows:

BODY CLAMP (two words, all caps.)

A2. Kat'z Deli agrees not to commit BODY CLAMP to any personal appearances, interviews or other promotion or appearance without prior written consent from BODY CLAMP or their representatives.

B. MATERIAL NEEDS

B1. Below is an outline of all desired objects to be provided IN HOUSE for the physical completion of this BODY CLAMP iterance.

- 2x Power drill(s) preferably WITH cord
- 2x Extension cord
- 1 pair sawhorse(s)
- Emergency sunscreen (partial use preferred)
- Access to beverage cooling device (mini fridge, cooler, etc.)
- Access to sound amplification device (for use with 1/8in. adapter)
- 1 Basket of fruit (from truck or street vendor)
- 2x Luon sheeting

B2. Below is an outline of all desired objects to be provided PERIPHERALLY for the physical completion of this BODY CLAMP iterance.

- Access to chopsaw
- Access to EITHER: A. table saw (PERIPHERAL) or B. circular/jigsaw (IN HOUSE)
- Liason(s) to area scrap material (2x4s, boards, sheets etc.)
- Photographic documentation by Amanda Katz or surrogate (to be scheduled)
